TRAGEDY APPEAL FOOTBALLER SUFFERS SPINAL INJURY

At Kingston Oval on July 7 2012 Kingston South East player **Trent Rothall**, in the process of tackling a Bordertown opponent, fell to the ground and fractured the vertebrae in his neck.

This day was also his 21st birthday, and he had intended to celebrate with family and friends at the football club that night.

Tragically instead he found himself being flown to the Royal Adelaide Hospital for emergency surgery and remained in intensive care for several weeks. Trent has recently been transferred to the spinal injury unit at the Hampstead Rehabilitation Centre where it is hoped the dedicated staff can help him regain as much movement as possible.

Currently Trent has very little movement in his biceps, and none elsewhere below his shoulders.

The rehabilitation process is going to be lengthy and will incur costs of hundreds of thousands of dollars to assist Trent recover to the best possible condition.

As is typical of country areas when faced with hardship, the Kingston and surrounding communities are doing a fantastic job in raising funds to assist the financial burden facing Trent's family.

THE GOOD SPORTS PROGRAM

The statement below is provided under the Liquor Licensing Act – Code of Practice – The Club will be implementing strategies that reflect, and comply, with the Code as set out below:

Service of Alcohol

The club will serve alcohol according to the Liquor Licensing Act 1997 and the Code of Practice and will ensure:

- Only Responsible Service of Alcohol (RSA) trained people shall be permitted to serve alcohol
- the club **shall not** encourage excessive or rapid consumption of alcohol, and thus will not conduct:
 - Happy Hours (unless conditions are approved by the GOOD SPORTS program)
 - Cheap drink promotions (unless conditions are approved by the GOOD SPORTS program)
 - Drinking competitions
 - "All you can drink" functions
 - Alcohol only member awards or raffle prizes
 - Alcohol only drink vouchers

When serving non pre-packaged alcohol (e.g. drinks in glasses), standard drink measures shall be served at all times.

At the Executive Committee meeting held Tuesday evening the following changes to our After-Match rewards scheme shall be implemented:

Meal vouchers shall be provided in lieu of "Drink Cards" and the "Mug" reward shall be replaced by a non-alcohol system.

And we have commenced initiating the processes to become a GOOD SPORTS CLUB
